#### PREAMBLE

The Shevchenko Foundation is a national, chartered philanthropic institution dedicated to the preservation, promotion, and development of Ukrainian Canadian cultural heritage, and to the advancement of a flourishing Ukrainian community for the enrichment of Canada.

#### **BACKGROUND - CANADIAN WWI INTERNMENT LEGACY**

The Shevchenko Foundation maintains \$10 million as an endowed fund known as the Canadian WW1 Internment Legacy (formerly Canadian First World War Internment Recognition Fund) The mandate of the Legacy fund is to support projects that commemorate and recognize the experiences of ethno-cultural communities affected by the First World War Internment operations while sharing the cultural contributions of these communities to Canada. With returns on the investment in this Legacy fund the Shevchenko Foundation continues to honor the Legacy of the Internment.

#### **COMMUNITY STEWARDSHIP**

The Shevchenko Foundation fulfills the mandate of the CANADIAN WWI INTERNMENT LEGACY by disbursing grants in support of various initiatives from groups and individuals in the fields of the Arts, Education, and Heritage Preservation.

The Shevchenko Foundation's grant-giving stewardship extends priority to projects and programs that:

- Commemorate and recognize the experiences of ethno-cultural communities affected by WWI Internment operations.
- Disseminate Ukrainian Canadian cultural contributions, and the cultural contributions of affected communities impacted by Canada's WWI Internment operations, to a broad and diverse public on a community, regional and national levels;
- Exhibit financial capability to undertake and sustain the project and/or program within the boundaries of a business plan, either as an organization or an individual;
- Demonstrate their feasibility by providing a best-practice model for the delivery of all stages of the project, can provide evidence of realistic budgets, and can provide evidence of financial and/or in-kind supports from other sources.

#### **ELIGIBLE PROJECTS: ARTS & EDUCATION**

- Academic research, publications, and educational materials linked to learning about the Canadian WWI Internment operations;
- Publication of books and other educational materials for Canadian children and youth to support study of the Canadian WWI Internment in public and private schools, heritage schools and secondary institutions;
- Development of internet-related digital content related to learning about the Canadian WWI Internment operations;
- Creation or development of an artistic initiative linked to the Internment story or significant enhancement of an existing artistic initiative thematically related to the WWI Internment;
- Performance and production costs, related to an artistic initiative, including touring and exhibition;
- Publication of individual works (including self-published) and large-scale works of reference by recognized and established publishers for both scholarly and general audiences.

#### Projects in the Arts or Education are funded up to 50% of the total project costs.

#### **ELIGIBLE PROJECTS: HERITAGE PRESERVATION & COMMEMORATION**

- Design, fabrication and installation of heritage markers, plaques, monuments, interpretive displays, that provide information on the history of WWI Internment in Canada;
- Conferences, workshops, establishment of partnerships and networks;
- Feasibility studies for preservation, rehabilitation, and restoration of historically significant Canadian Internment linked sites, cemeteries, or historically related structures threatened by damage or destruction;
- Commemorative activities in remembrance of the WWI Internment operations and victims of those operations.

# Projects related to Heritage Preservation and Commemoration are funded up to 100% of the total project costs.

#### NOTES TO ELIGIBLE PROJECTS

Priority will be given to projects that engage collaboration, partnership, and/or coproduction, with experienced mentors and/or existing organizations, arts centres or festivals.

Projects that fulfill requirements for a degree or a diploma are not eligible. Expenditures for yearly overhead expenses of an organization or educational entity are not eligible.

#### WHO IS ELIGIBLE?

#### **Organizations:**

- Canadian not-for-profit community organizations, artists and artist collectives, whose activities occur primarily in Canada, and Canadian chartered educational institutions.
- Canadian not-for-profit professional, semi-professional and amateur groups governed by a board of directors or a body responsible for the organization.
- NOTE: It is the responsibility of organizations working with children under the age of 18, who are funded by the Shevchenko Foundation, to ensure that they follow youth protection policies and procedures in their jurisdictions.

#### Individuals:

- Must be Canadian citizens or permanent residents at the time of application.
- Must be supported by two (2) letters of reference from peers or others familiar with the applicant's body of work, experience in the field, and ability to undertake and deliver the project.

#### HOW OFTEN CAN ONE APPLY?

- No new application will be accepted if a Final Report has not been submitted from a previous grant.
- Applicants who are applying for more than one grant in the calendar year can do so only when the Final Report on the first project has been approved by the Shevchenko Foundation.
- Applications for projects that are phased over more than one year will be accepted. Funding will be granted in phases, subject to meeting annual reporting requirements.

#### **APPLICATION DEADLINE**

Unless otherwise specified, deadlines for grant applications are APRIL 1 for projects beginning after July 1, and OCTOBER 1 for projects beginning after January 1.

#### ADDITIONAL INFORMATION

- Grant applications must be made in advance of the starting date of the project.
- Submission of an application is not a guarantee that the Shevchenko Foundation will provide financial grant assistance.
- The Shevchenko Foundation funds from 50% to 100% of total project or program costs of successful applications to the Canadian WWI Internment Legacy Fund contingent upon budget resources for the given grant deadline.
- The Shevchenko Foundation strives to create a balance between supporting established returning applicants, new applicants, and applicants exploring emerging practices in the broad scope of cultural development.
- Grants can be used to cover costs and expenses associated with the project, but cannot be used to cover expenses for general living allowances for project participants.
- The Shevchenko Foundation does not claim any copyright on projects receiving funding.
- Please check the Shevchenko Foundation website for any posted changes to eligibility and/or assessment criteria.

#### ASSESSMENT

The Shevchenko Foundation's assessment for funding assistance is guided by integrity, sustainability, excellence, innovation, and inclusiveness of all Canadians who support the mandate of the Shevchenko Foundation.

When assessing applications, the Foundation applies the following questions.

- Are the goals for the project and those undertaking the project well-articulated?
- Are the goals for the project within the scope of the Canada WWI Internment Legacy Fund?
- How does the project advance the relevancy of the Canadian WWI Internment Legacy Fund by connecting people and strengthening communities for the enrichment of Canada?
- How well does the project articulate accommodating changing demographics, changing patterns of consumption, changing forms of dissemination?
- Are the indicators for success of the project within the organizational and human resources capacity of the applicant?
- How realistic is the financial viability of the project?
  - What are the consequences and contingencies for project shortfalls? How will the project still be viable if it does not receive the projected revenues in grant support and public support?
  - Is there evidence of sound fiscal management, a track record of fiscal responsibility, and sound budgeting?
  - How realistic are budget revenue projections? Are cost estimates well researched?

- What is the demonstrated value of funding a project application if it does not generate earned revenue from ticket sales, donations, or fundraising?

  - INDIVIDUALS: Articulate how this project is important to the development of your artistic practice or career, and how it impacts the story of the CANADIAN WWI INTERNMENT LEGACY.
